

HENGELREËLS / ANGLING RULES:

General:

1. It is a boat- and shore-angling competition.
2. Hengelkompetisie vind vanaf Vrydag, 25 November 2011 van 17:00 tot Sondag, 27 November 2011 om 09:00 plaas. Dag- en nagkompetisie.
3. **No angling permitted after 13:00 on 25 November 2011 until 17:00 when the tournament starts.**
4. Target fish species: carp (excluding grass carp, except for heaviest bag grass carp) and barbel.
5. Participants must register at gates. Deelnemers moet asseblief verseker dat hulle persoonlike besonderhede korrek afgeneem word by registrasie.
6. Only registered participants may participate in Bonanza.
7. Open-line class: two rods per angler.
8. Deelnemers moet self visstok werp en vis inbring.
9. Hounette en lewendige aashouers ("livewells") sal voor kompetisie nagegaan word.
10. Deur in te skryf, aanvaar deelnemers die hengelreëls.
11. Any participant who contravenes the angling rules will be disqualified.
12. Appeal board's decision is final.
13. Jy moet te enige tyd op versoek van 'n beampte jou inskrywingsbewys kan toon.
14. Reg van toegang voorbehou. No refunds.
15. Organiseerders kan nie vir 'n borg wat onttrek, instaan nie.
16. Littering and collecting of wood on the premises is prohibited.
17. Damreëls van die SAPD, oorde en provinsies geld.
18. Geen motorfietse, vierwielmotorfietse ("quad bikes") en troeteldiere by oorde toegelaat nie.

19. Enige navrae of besware oor uitslae, beslissings, reëls en reëlings tydens die hengelkompetisie moet voor die afloop van die kompetisie of binne 24 uur daarna skriftelik by die hooforganiseerder Chris Schutte (082 440 5398) aangemeld word vir hantering deur die appèlraad. Geen navrae sal daarna hanteer word nie.

Oewerhengel:

20. Die hele oewer van Bierman se plaas en aangrensende oewer, uitgesonderd die gedeeltes gereserveer vir boothengelaars en borge.
21. Jy kan alleenlik plek hou vir soveel laatkommers as waarvoor jy inskrywingsbewyse aan hoofoewerbeampte kan toon.
22. Canoes, bait boats and one-man trolling motor boats are permitted. Life jackets must be used.
23. Geen petrolaangedrewe bote mag gebruik word om aas uit te neem nie.

Boat angling:

24. Launching from the official launching site only.
25. Only participants on boats. No passengers.
26. No boat fishing within 300 metres of shore anglers.
27. No boats allowed to beach at the shore-angling areas.
28. Geen boothengelaars in oewerhengelseksie toegelaat nie.
29. Boat anglers not allowed to beach on private property.
30. Boats must comply with SAMSA requirements and have the necessary safety equipment. Life jackets!
31. Boats equipped with night navigation equipment are allowed at their own risk on the dam during the night.
32. Boats not allowed to cruise on the water after sundown (must stay anchored).
33. Skippers must complete "SAPS lock-in control document" and hand it back to official before launching. The lock-in document is available at Registration at the entrance.

Inweeg:

33. Hengelkaartjie moet getoon word om vis te kan weeg.

34. 'n Deelnemer bevestig met sy handtekening op inweegstrokie dat sy persoonlike besonderhede en gewig van die vis korrek is.
35. Weigh-in times: Saturday 08:00-09:00; 15:00-17:00. Sunday 06:00-10:00. Weigh-in ring closes at 10:00.
36. Oewerhengel se vis word deurentyd by sy staanplek deur beampte ingeweeg. Boothengel weeg in by bootlansering.
36. Vis wat geweeg word, word die eiendom van die organiseerders.
37. Only your biggest fish of a species will be weighed. Rather catch and release. Slegs visse wat groot genoeg is om vir 'n prys in aanmerking te kom, sal geweeg word.
38. It is in your own interest to weigh your fish for Big Banger prizes immediately.
39. No bags loaded with target fish will be allowed at weigh-in.
40. No culling at the weigh-in allowed.
41. Only live fish will be weighed. No damaged fish will be weighed.
42. Each participant must have his or her own keepnet or livewell.
43. Wenvisse kan chemies en morfologies ontleed word om vas te stel of hulle uit Vaaldam kom en wanneer hulle gevang is.

Prize-giving

44. Participants must be at prize-giving and present their angling ticket to be considered for any prize.
45. You can only win one prize per fish.
46. One prize per participant (Big Bangers and lucky draws excluded).
47. All participants automatically qualify for all prizes in the fishing tournament. The computer weigh-in program will sort out the winners of the different prizes.
48. The Open-class prizes will be awarded for most points according to the Eco-Care Fishing Table for two different target fish species weighed together.
49. The Top 15 shore prizes and Top 10 boat prizes will be awarded for the most points for a single target fish species according to the Eco-Care Fishing Table.
50. In case of a tie the winner will be determined by a draw.

51. “Big Banger 1” Grootste **babber bo 21,9 kg** gevang vanaf ’n boot wen TATA XENON-bakkie ter waarde van R120 000.
52. “Big Banger 2” Grootste **babber bo 17 kg** gevang vanaf die oewer wen veldsloopwa ter waarde van R125 000.
53. “Big Banger 3” Motorboat prize worth R157 000 for the most points for two target fish species weighing in excess of **1 700 points** according to the Eco-Care Trust Table, fishing from the boat or from the bank, whichever got the most points.
54. “Big Banger 4” **Grootste karp bo 8,3 kg** deur ’n boothengelaar gevang wen R30 000 kontant.
55. “Big Banger 5” **Grootste karp bo 7,5 kg** deur ’n oewerhengelaar gevang wen R30 000 kontant.
56. Swaarste sak graskarp wat geweeg word wen **R1 000**.
57. “Keep the dam Clean” Competition. You must hand in your bag with litter and tear-off slip at Lucky Draw Box.
58. “Water is Lewe”-kompetisie. Handig jou kaartjie in.
59. Painsdane pre-entry lucky draw. Get a stamp on the back of your angling ticket when you arrive at the gates.
60. The organisers reserve the right not to hand out any specific prize when foul play or any irregularity is suspected.

Sportmangees; boot- en oewerhengelaars respekteer mekaar se regte.

Drankmisbruik en onbeheersde gedrag sal nie geduld word nie. Oortreders sal aangekla en deur die SAPD van die terrein verwyder word.
